

# SEASONAL LOCKER LOTTERY

## *Victor Constant Ski Area*

### Standing Operating Procedure

1. GENERAL:

There are 140 seasonal lockers on the lower floor of the Class of '48 Ski Lodge available for rental annually for occupancy by eligible patrons. Seasonal lockers are capable of holding two (2) sets of skis, boots and poles, or four (4) pairs of skis. Occupants are selected via a lottery system, as prescribed below, from applications received.

2. ELIGIBILITY:

Season locker occupants must be authorized IAW Army Regulation 215-1.

3. SEASON:

- a. Seasonal lockers may be occupied from **22 Nov 2009 thru 1 Apr 2010**.
- b. Victor Constant Ski Area closes in mid-March. Equipment and locks must be removed from seasonal locker by 1 Apr 2010. Access to Ski Lodge is not permitted after this date as Victor Constant Ski Area will be closed and inaccessible. Items left behind are assumed property of the Victor Constant Ski Area.

4. LOTTERY:

- a. The Lottery consists of two (2) categories: Active Duty and All Others. All Active Duty applications will be considered first with All Others after all Active Duty applicants are selected/exhausted.
- b. Lottery applications will be available at [westpointmwr.com](http://westpointmwr.com) beginning on 19- October and must be submitted by 17- November 2009.
- c. After all seasonal lockers are filled; a waiting list will be started from the remaining applications and will be entertained in the order of eligibility as they are drawn.
- d. Lottery winners will have the option to request one (1) preferred locker number. If that locker is not available, one will be issued as close to that locker as possible. Selection of preferred locker is NOT guaranteed. Please refer to locker layout form to determine locker location.
- e. Only one (1) Lottery application will be accepted from each household unless there are two members on Active Duty in the same household.

5. PAYMENT:

100% of the seasonal locker fee must be paid during the annual Ski Swap, 22 & 23 Nov 2009 or thru the Ski Area, Sales and Ticket Office beginning 14 Dec 2008 thru 23 Dec 2009 during advertised hours of operation. **Failure to satisfy payment deadlines will result in forfeiture of reservation.** Unpaid lockers will be redistributed from waiting list beginning 1 January 2010.

6. POLICIES:

- a. Occupancy of a seasonal locker is by the approved eligible lottery winner or immediate family only.
- b. Subletting or selling of seasonal locker privileges is prohibited.

- c. Penalty for violation of policies may result in cancellation of seasonal locker with no refund.
- d. Applications will be accepted for 30 days from posting date on 19- October 2009.
